IN ADDITION TO DELICIOUS (AND HEALTHY) FARE, THE CAFE OFFERS DIGNIFIED WORK AND JOB SKILLS TRAINING FOR MEN AND WOMEN TRANSITIONING OUT OF INCARCERATION AND IS HOME TO EXTENSIVE ARTS AND CULTURAL PROGRAMS.

PIZZA SHOP - IN OCTOBER 2015, HALEY HOUSE OPENED A GOURMET PIZZA SHOP AS A PILOT MODEL OF A BUSINESS FOCUSED ON WORKER EMPOWERMENT. THE RESTAUREANT HAS BEEN DESIGNED WITH A STAFFING STRUCTURE TO FOSTER ECONOMIC INCLUSION AND EMPOWERMENT FOR LOW-SKILL, ENTRY-LEVEL WORKERS AND IS ROOTED IN THE VISION OF A MORE INCLUSIVE AND CONNECTED WORLD.

ON DECEMBER 15, 2017, THE ORGANIZATION DETERMINED TO DISCONTINUE ITS PIZZA SHOP OPERATIONS. BASED ON CLOSE BUSINESS ANALYSIS OF OPERATIONS AND TRENDS, THE BOARD DETERMINED THAT HALEY HOUSE COULD NOT CONTINUE TO SUBSIDIZE THE OPERATION.

FOOD AND FARMING PROGRAM - EACH YEAR SOUP KITCHEN VOLUNTEERS SERVE MORE THAN 36,000 MADE-FROM-SCRATCH MEALS AND DISTRIBUTE OVER 10,000 BAGS OF FOOD THROUGH THE WEEKLY FOOD PANTRY. THESE PROGRAMS ARE COORDINATED BY A LIVE-IN COMMUNITY OF LONG-TERM VOLUNTEERS WHO DONATE THEIR TIME IN EXCHANGE FOR BOOM AND BOARD. HALEY HOUSE ALSO FARMS TWO PLOTS OF RECLAIMED URBAN LAND, WHICH PROVIDE SEASONAL PRODUCE FOR THE SOUP KITCHEN, BAKERY CAFE, AND PIZZA SHOP. OTHER FOOD PROGRAMS INCLUDE TAKE BACK THE KITCHEN, A HANDS-ON COOKING PROGRAM TAUGHT BY PROFESSIONAL CHEFS REACHING OVER 400 YOUNG PEOPLE AND THEIR FAMILIES EACH YEAR AND COMMUNITY TABLES, A LOCALLY SOURCED, FAMILY FRIENDLY PAY-WHAT-YOU-CAN DINNER.
